

19th Meeting of the Regional Steering Committee of the GF-TADs of the Americas

Agenda

Background

Since 2005, the Regional Steering Committee of the Global Framework for the Progressive Control of Transboundary Animal Diseases (GF-TADs) has identified Cochliomyia hominivorax myiasis (NWSW) as one of the priority Transboundary Animal Diseases (TADs).

In November 2016, during the 8th RSC Meeting held in Bolivia, one of the conclusions was to consult the members regarding the update of priority diseases.

As part of the recommendations resulting from the 14th RSC Meeting, which was held virtually, NWSW remained one of the prioritized TADs.

The spread of this infestation has been escalating towards the northern countries of the continent, now affecting the entire Central American region with the reappearance of a disease that had been eradicated for nearly 30 years. It has reached recently Mexico, posing a high risk of incursion into North American countries.

Objectives

The objectives of the meeting are:

Establish the Standing Group of Experts on Cochliomyia hominivorax Myiasis (SGE-NWSW).

Approve the Terms of Reference for the operation of the SGE-NWSW.

Define priority strategies to address reinfestation in countries where it had been eradicated and prevention measures in countries that remain free of the disease.

Present the regional situation of NWSW.

Approach and Expected Outcomes

• The meeting will focus on formally establishing the Standing Group of Experts on Cochliomyia hominivorax Myiasis (SGE-NWSW), approving the Terms of Reference that will define its operation, and setting priority strategies to







address reinfestation in countries where the pest had been eradicated, as well as preventing its introduction into disease-free countries. Additionally, an updated overview of the regional situation will be presented, consolidating epidemiological information and strengthening regional commitment to implementing joint and effective actions for the prevention and control of this disease.

- The meeting will be conducted with a participatory, technical, and strategic approach, aiming to integrate the
 expertise and knowledge of specialists to consolidate agreements on priorities and strategies related to Cochliomyia
 hominivorax. This will facilitate the establishment of a clear structure for the SGE-NWSW, defining roles,
 responsibilities, and coordination mechanisms among its members.
- It will also assess the participants' experience of enhancing the group's capacity in designing and executing regional strategies.

Expected Outcomes

- Formalization of the group with a defined organizational structure and an initial work plan.
- Official Terms of Reference (ToR) document approved by consensus, including clear objectives, member responsibilities, and monitoring and evaluation mechanisms.
- Improvement of early detection, updating guidelines for best practices in animal handling and movement.
- Implementation of a fast and interactive mechanism for the timely delivery and exchange of information on the regional situation of Cochliomyia hominivorax, including epidemiological data, identified risks, and critical areas. This will support decision-making and optimize intervention strategies.
- Reinforced cooperation and coordination among countries for a sustainable and effective regional approach to prevention and control.
