





Second meeting of the GF-TADs Standing Group of Experts on Avian Influenza (SGE-AI) Mexico City, Mexico, April 19th - 21st, 2023

Agenda

Background

Since 2004, the Food and Agriculture Organization of the United Nations (FAO) and the World Organization for Animal Health (WOAH) have cooperated in the Global Framework for the Progressive Control of Transboundary Animal Diseases (GF-TADs) to reduce the threat from transboundary animal diseases (TADs) to food security, livelihoods and safe trade.

On April 2005, WOAH and FAOUNES launched the GF-TADs for the Americas, with the participation of international and regional organizations. Since its creation, it has promoted and provided an effective coordination platform.

Regarding latest Avian Influenza outbreaks in the Americas, it is agreed that its prevention and control requires coordination between national veterinary authorities and relevant stakeholders. For that, the first meeting of the *GF-TADs Standing Group of Experts on Avian Influenza* (SGE-AI) was held in December 2022 and produced relevant recommendations for countries and organizations in the region.

Some of its recommendations aim at the interface between domestic and wild birds, including the need of biosecurity measures at high-risk environments, such as the areas of congregation of wild migratory birds. In addition, surveillance as well as disease notification in wildlife is encouraged. Considering the specific approach required for wildlife surveillance and management, this meeting shall provide information on the disease and its impact on wildlife, as well as relevant tools and a platform for sharing success stories and best practices.

Also, the meeting shall provide an approach on trade for wild birds and poultry, as well as the measures to grant its continuity in case of an outbreak, using the WOAH Standards as a basis. Other relevant topics shall be presented including the laboratory diagnostic tools for granting an accurate and timely diagnosis, as well as the current discussions on the use of vaccines for the prevention of the disease.

All the previous topics and facilitated discussions with speakers shall provide feedback and guidance for the work carried out by the GF-TADs Standing Group of Experts on Avian Influenza and define future regional actions.

Objectives

Meeting aims to:

- · Provide information on existing global and regional platforms, programs, and action plans
- Present the global and regional situation of Avian Influenza
- Discuss national strategies and management options applied in the Americas, focusing on surveillance, prevention, emergency preparedness and response.
- Discuss the safe trade of poultry, wild birds, and their products through the implementation of the WOAH standards.
- Identify main topics and priorities for the development of a regional framework for the prevention and control of disease in the Americas.

Approach and expected outputs.

A short briefing on the epidemiological situation shall be presented, focusing on findings in different relevant wildlife animal species. In addition, ongoing initiatives at global and regional level to promote national activities integration in different frameworks will be presented, as well as updated information on laboratories capacities, impact of the disease on trade, and vaccination.







Interactive and group sessions as well as discussions shall provide participants the opportunity to exchange their challenges and positive the national level as well as reach common topics to be part of a regional strategy. Discussions shall also consider the potential synergies for capacity development that would contribute to better preparedness against other priority TADs in the region.
